Use the Amendment to Publication agreement to extend your rights to ...

USE, REPRODUCE, DISTRIBUTE, CREATE derivative works including update, perform, and display publicly, the Article in electronic, digital or print form in connection with the Author's teaching, conference presentations, lectures, other scholarly works, and for all of Author's academic and professional activities.

BENEFITS:

- Provides you the right to make reproductions of your work for teaching, research, and scholarship
- Provides you the right to post your work to your web site or course management system

EXERCISE YOUR RIGHTS:

Once the article is published ...

MAKE, OR AUTHORIZE OTHERS TO MAKE, the final published version of the Article available in digital form over the Internet, including but not limited to a website under the control of the Author or the Author's employer or through any digital repository (e.g. National Library of Medicine's PubMed Central database).
